And now, may I call upon Mr. Guy Laframboise, Chair of the St. Mary's Hospital Foundation, to open the Annual General meeting and to begin the proceedings.

As we proceed with the formal part of the Foundation's AGM, I am pleased to see a good representation of the St. Mary's Community at large joining us today.

At this time I ask all past and current Members of the Foundation Board to please stand... Thank you for your unrelenting support in rallying the greater Montreal Community to fund the priority needs of "our" Hospital ... your attendance today is paramount to us moving forward. Thank you – I attest that there is quorum.

The first item on the agenda is to ask Arthur Wechsler, Secretary of the Foundation, to read the notice of today's meeting covering fiscal year April 1, 2018- March 31 2019 as published in *The Gazette* and *La Presse*.

In accordance with article 177 of the Act respecting health services and social services, the notices for today's meeting were published in *The Gazette*, on Friday August 31, 2019 and in *La Presse* on Thursday September 5, 2019. A copy is available at the table at the back of the room for those wishing to see it.

Thank you Arthur. Guy Laframboise asked for a *motion to approve the AGENDA as presented to the members proposed by Don Bastien and seconded by Donald Clarke and all in favour and unanimously approved. Motion carried.*

Guy asked for a motion to approve the minutes from October 2, 2018 St. Mary's Hospital Foundation AGM proposed by John Mancini and seconded by Donald Clarke and all in favour and unanimously approved. Motion carried.

I am very pleased to report that the Foundation Board has completed its review of all governance policy and procedures and that they all hold current and true and are available, at your convenience on our website.

At this time I would like to ask Doug Buchanan, the Treasurer of the Foundation and Chair of the Finance Committee, to join me and present highlights of the audited financial statements as well as table a resolution to appoint auditors for the 2019-2020 fiscal year.

Financial Highlights as presented by Doug Buchanan, Treasurer:

Good afternoon. Bonne après-midi. The financial statements of the Foundation for the year ending March 31, 2019 were audited by the firm Samson, Belair, Deloitte & Touche.

No material issues were raised during the audit process. On the balance sheet, we see that the Foundation had on March 31 assets of \$28.4M, versus \$26.2M for fiscal 2018.

Direct fundraising declined by \$500K year-over-year, decreasing to \$5.4M. Investment income increased to \$1.4M in fiscal 2019, resulting in total revenues of \$6.8M, remaining even with revenues reported in fiscal 2018. Importantly, the value of the Foundation's investment portfolio increased by \$3.8M during the fiscal year, putting the Foundation in good stead for the future. Salaries and Administrative and fundraising expenses for the Foundation were \$981K - in line with approved budgets.



On note qu'en terme de revenus, la Fondation a amassé 5.4M\$ provenant des efforts de levée de fonds. La valeur de nos placements a augmenté de 1.4M\$. Donc les revenus globaux pour l'année sont 6.8M\$. La Fondation a versé au Centre Hospitalier plus que 3M\$. The Foundation donated over \$3M to the Hospital during the fiscal year. These monies were directed to the hospital's priorities as determined by the institution's administration. Les états financiers vérifiés ont été soumis au conseil d'administration de la fondation et fut approuvé tel quel. The audited financial statements were submitted to the board of directors and approved as presented.
